

Exhibit A Limited Warranty for Meteor LED and Solar LED Products

This Limited Warranty ("Warranty") is provided by Meteor Lighting ("Meteor" or "Seller") to the original buyer of the Meteor product as identified on Meteor's invoice ("Buyer") and is subject to the provisions and terms and conditions as set forth in this document ("Warranty Terms and Conditions").

I. Limited Warranty

Subject to the Warranty Terms and Conditions, Meteor warrants that, when delivered in new condition and in its original packaging, the Product shall be free from defects in materials and workmanship as follows: (a) up to five (5) years from the date of original purchase for LED products (luminaires), excluding solar products; or (b) up to three (3) years for solar LED products from the date of original purchase, excluding non-solar products.

If Meteor, in its sole and absolute discretion, determines that the Product is defective, Meteor will elect, in its sole and absolute discretion, to refund Buyer the purchase price of the Product, provide a replacement Product, or repair the Product, provided that Buyer complies with all Warranty Terms and Conditions. A Product shall not be defective if the number of inoperable LED components to emit light is less than five percent (5%) of the total number of LEDs in the Product. Meteor's sole obligation under this Limited Warranty is to repair or replace any defective parts or products, as determined by Meteor in its sole and absolute discretion, providing such allegedly defective Products are brought to its attention within the specified warranty time period and delivered to Meteor. No refund will be issued unless specifically approved by Meteor in writing.

II. Warranty Claims

To make a warranty claim, (1) Buyer must notify Seller in writing within thirty (30) days after discovery or knowledge of the defect or damage. (2) Buyer shall at its sole cost and expense return Product(s) for inspection with a bill of sale or other evidence showing the date of purchase and identification of the original Purchaser, but no Product(s) or component part(s) will be accepted for inspection, verification or return unless accompanied by a Meteor Return Merchandise Authorization ("RMA") number, which can be obtained only from an authorized Meteor post-sales or customer service representative. Meteor is not responsible for any costs and expenses incurred in connection with shipment of Product(s) to and from Meteor, except that Meteor shall pay for regular ground shipping for any replacement Product(s) to the customer if Meteor determines the Product(s) are defective. (3) If upon inspection and testing of the returned Products by Meteor, such Products are found to be defective and not has not been caused by the exclusions detailed below, Meteor shall, at its sole discretion, repair, replace or refund such Products; and (4) the Purchaser shall prepay all of Meteor's costs and expenses (including risk of loss) for the delivery of all repaired or replaced Products to the Purchaser.

III. Terms and Conditions

Notwithstanding anything to the contrary, this Warranty is void if: the Product is not used for its intended purpose; or if any repairs, alterations or modifications not duly authorized by Meteor in writing are made to the Product by any person; any unauthorized return of Product.

Notwithstanding anything to the contrary, this Warranty excludes any fees, costs, labor and service charges related to the repair, disassembly, installation, reinstallation, removal, replacement of the Product, any administrative costs or requirements of law or any governmental agency or body. In addition, this Warranty excludes any costs or charges resulting from installation of third party components, failures of third party supplied components, or failures of Meteor supplied Product(s) caused or in association with any third party supplied component.

This Warranty applies only to the use of the Product(s) as intended by Meteor. This Warranty applies only when the Product(s) are installed in applications in which ambient temperatures are within the range of specified operating temperatures and are operated within the electrical values shown on the LED driver Label or Meteor's specifications.

Meteor shall not be responsible under this Warranty for any failure or non-compliance of the Product(s) that results from causes such as: acts of nature or God; physical damage; exposure to adverse or hazardous chemical or other substances; use of reactive cleaning agents and/or harsh chemicals to clean the Product(s); environmental conditions; vandalism; fire; power failure, improper power supply, power surges or dips, electrical current fluctuations, and/or excessive switching; induced vibration; animal or insect activity; corrosive

environmental installations, induced vibration, misuse, abuse, mishandling, improper installation, storage or maintenance, fault or negligence of purchaser, any changes or modifications to the Product, any end user of the Product(s) and/or any third party not engaged by Meteor; improper or unauthorized use, abuse, misuse, abnormal use, or use in violation of any applicable standard, code, or instructions for use including, without limitation, those contained in the latest safety, industry and/or electrical standards for the relevant region; improper installation, handling, storage, alteration, maintenance or service, including failure to abide by any product classifications or certifications, or failure to comply with any applicable standards, codes, recommendations, product specification sheets, or instructions of Meteor; use of, integration with, and/or compatibility of the Product(s) with other third party products, software, controllers, devices, processes or materials ; any substantial deterioration in the Product finish that is caused by failure to clean, inspect or maintain the finish of the Product(s); or any other occurrences beyond Meteor's reasonable control.

If the Product(s) are used on existing foundations, anchorages or structures, the end user is solely responsible for the structural integrity of such existing foundations, anchorages or structures and all consequences arising from their use. Adequate records of operating history, maintenance, and/or testing must be kept by the end user and provided to Meteor upon request to substantiate that the Product(s) have failed to comply with the terms of this Warranty. Neither polycarbonate nor acrylic material used in the Products is warranted against yellowing, as yellowing may naturally occur over time due to normal aging. The Product(s) are not warranted against costs that may be incurred in connection with changes or modifications to the Product(s) required to accommodate site conditions and/or faulty building construction or design.

For purposes of providing any replacement Product under this Warranty, Meteor reserves the right, in its sole and absolute discretion, to use new, reconditioned, refurbished, repaired or remanufactured parts or products for any Products subject to this Limited Warranty, and such parts and products shall be comparable in performance and function to the original product and warranted for the remainder of the original warranty period from the original date of purchase.

No agent, sales representative, distributor, or dealer is authorized to change, modify, or extend the terms of this Warranty on behalf of Meteor.

IV. Limitation of Liability

TO THE FULL EXTENT ALLOWED BY LAW, IN NO EVENT SHALL METEOR BE LIABLE FOR ANY LIABILITY, WHETHER BASED IN CONTRACT, WARRANTY, PERFORMANCE OR BREACH OF THIS WARRANTY, OR TORT (INCLUDING NEGLIGENCE), FOR INCIDENTAL, COMPENSATORY, CONSEQUENTIAL, INDIRECT, SPECIAL, OR PUNITIVE DAMAGES OF ANY KIND OR FOR LOSS OF REVENUE OR PROFITS, LOSS OF BUSINESS, OR OTHER FINANCIAL LOSS ARISING OUT OF OR IN CONNECTION WITH THE SALE, INSTALLATION, MAINTENANCE, USE OR MISUSE, PERFORMANCE, FAILURE, OR INTERRUPTION OF ITS PRODUCTS, EVEN IF METEOR HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES. NOTWITHSTANDING ANYTHING TO THE CONTRARY, METEOR'S AGGREGATE LIABILITY WITH RESPECT TO A SINGLE DEFECTIVE PRODUCT SHALL IN ANY EVENT BE LIMITED TO THE MONIES PAID TO METEOR BY BUYER FOR THAT SINGLE DEFECTIVE PRODUCT.

THE FOREGOING WARRANTY PROVISIONS ARE EXCLUSIVE AND ARE GIVEN AND ACCEPTED IN LIEU OF ANY AND ALL OTHER WARRANTIES AND REPRESENTATIONS, WHETHER EXPRESS OR IMPLIED, INCLUDING WITHOUT LIMITATION ANY WARRANTY AGAINST INFRINGEMENT AND ANY IMPLIED WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE. ANY ADDITIONAL OR INCONSISTENT TERMS REGARDING WARRANTY IN BUYER'S PURCHASING DOCUMENTS OR AGREEMENT SHALL BE DEEMED EXPRESSLY REJECTED BY METEOR.

THE TOTAL LIABILITY OF METEOR ON ANY AND ALL CLAIMS OF ANY KIND, WHETHER IN CONTRACT, WARRANTY, TORT (INCLUDING NEGLIGENCE), STRICT LIABILITY OR OTHERWISE, ARISING OUT OF OR IN CONNECTION WITH, OR RESULTING FROM, METEOR'S PERFORMANCE OR BREACH OF THIS WARRANTY, OR FROM METEOR'S SALE, DELIVERY, RESALE, REPAIR, OR REPLACEMENT OF ANY PRODUCT(S) OR THE FURNISHING OF ANY SERVICES, SHALL IN NO EVENT EXCEED THE PURCHASE PRICE ALLOCABLE TO THE DEFECTIVE PRODUCT(S) THAT GIVE RISE TO THE CLAIM, AND ANY AND ALL SUCH LIABILITY SHALL TERMINATE UPON THE EXPIRATION OF THE WARRANTY PERIOD SPECIFIED ABOVE.
